A certain tract of land near Colonias, Taos County, New Mexico, within the Antonio Martinez Grant, and located within the N.W. 1/4 of Projected Section 31, Township 26 North, Range 13 East, N.M.P.M.; also described as part of Tract 26, Map 12, Survey 2 of the 1941 Taos County Reassessment Survey, and more particularly described by notes and bounds as follows:

BEGINNING at a 5/8 inch rebar found for the E. corner of this tract, from whence Corner No. 2, Private Claim 40, Parcel 3, a U.S.G.L.O. brass cap monument on the W. boundary of the Taos Pueblo Grant bears S. 48° 28' E., 3346.3 feet distant, thence; S. 48° 39' W., 397.8 feet to a 5/8 inch rebar found for the S. corner on the northeasterly right-of-way of a 40 foot road, thence along said right-of-way; N. 40° 03' W., 219.1 feet to a 5/8 inch rebar found, thence; N. 39° 57' W., 221.0 feet to a 5/8 inch rebar found for the W. corner, thence leaving said right-of-way; N. 48° 57' E., 393.4 feet to a 5/8 inch rebar found for the N. corner, thence; S. 40° 46' E., 220.6 feet to a point, thence; S. 40° 22' E., 219.8 feet to the point of beginning.
