

ARTICLES OF INCORPORATION
OF
DOS ARROYOS SUBDIVISION HOMEOWNERS ASSOCIATION

The undersigned certifies that he has this day formed a nonprofit corporation under the New Mexico Nonprofit Corporation Act, New Mexico Statutes Annotated, Section 53-8-1 et. seq., as amended, and does hereby adopt the following Articles of Incorporation:

Article I

The name of the corporation is: Dos Arroyos Subdivision Homeowners Association.

Article II

The period of duration of the corporate existence of the corporation is to be perpetual.

Article III

The purposes of the corporation is as follows: to own, operate, manage, maintain, repair and improve, drainage, roads, open space, trails, and utility easements of Dos Arroyos Subdivision, Taos, Taos County, New Mexico; to enforce the Declaration of Easements, Covenants, Conditions and Restrictions for Dos Arroyos Subdivision, filed in Book M-421 at pages 362 to 374, Records of Taos County, New Mexico, as Amended, from time to time, to hold and exercise all of the powers conferred by law upon nonprofit corporations organized under the laws of the State of New Mexico; and in general to carry on any lawful activity and perform any lawful act permitted by the laws of the State of New Mexico.

Article IV

Upon the dissolution of Dos Arroyos Subdivision Homeowners Association, its assets shall be distributed to either a public body or consistent with the provisions of Section 53-8-48, New Mexico Statutes Annotated, 1978, as amended.

Article V






